# 2. PUBLIC HEARING

Bylaw No. 1670/2010 being a bylaw to amend Bylaw No. 1184/98 being the Land Use Bylaw to amend the land use district for Lot 29-30, Block 19, Plan 1117V (418 5th Street S.E.) from R-1 Single Family Residential District to DC Direct Control District

A) Mayor Hazelaar called the Public Hearing for Bylaw No. 1670/2010 being a bylaw to amend Bylaw No. 1184/98 being the Land Use Bylaw to amend the land use district for Lot 29-30, Block 19, Plan 1117V (418 5th Street S.E.) from R-1 Single Family Residential District to DC Direct Control District to order at 7:04 p.m.

Sandy and Anna MacDonald, Stephen Pyke, Helen Strugari and Brenda Messenger were in attendance to discuss Bylaw 1670/2010. Mr. MacDonald advised that he was not in opposition to the Land Use Amendment as long as it did not increase the density of the dwelling. He commented that he did not want to see the occupancy of the house exceed 4 residents and suggested that this condition be considered by Council. He had no objection to the use of the residence beyond concern for the number of occupants.

The Municipal Manager noted that the Public Hearing is in regard to the change of land use from R-1 Single Family Residential District to DC Direct Control District and no conditions can be attached to the approval of a land use change. Conditions are considered when a development permit application is submitted by the land owner.

S. Pyke advised that the Champions Centre has allowed him and others to get their life back on track and that there is only room for 4 residents.

Members of Council expressed no comments or concerns regarding Bylaw 1670/2010 being a bylaw to amend Bylaw No. 1184/98 being the Land Use Bylaw to amend the land use district for Lot 29-30, Block 19, Plan 1117V (418 5th Street S.E.) from R-1 Single Family Residential District to DC Direct Control District.

4<sup>th</sup> Avenue & 2nd Street SE Intersection Remediation

i) In regards to 4<sup>th</sup> Avenue and 2<sup>nd</sup> Street SE remediation it was suggested that the remediation may result in a bumpy or uneven surface on 2<sup>nd</sup> Street. K. Minhas, Manager of Engineering advised that he has taken this into consideration and there may be a need for further grinding of the crown. It was noted that a 10% contingency was added to the contract to cover potential additional costs for the project including possible crown grinding.

Councillor Crozier moved to concur with the recommendation of the Manager of Engineering that the Town's Engineering department be authorized to obtain additional quotes from other contracting firms for 4<sup>th</sup> Avenue & 2nd Street SE Intersection Remediation. Further that the Engineering Department be authorized to begin the remediation work in the intersection of 4<sup>th</sup> Avenue and 2<sup>nd</sup> Street S.E. at a cost of \$15,950 (including 10% contingency) plus GST, to be funded from the Other Capital Projects Reserve. - Carried.

Policy 35, Sanitary Sewer Blockage Policy

**ii)** In regard to the proposed change to Policy 35, Sanitary Sewer Blockage Policy Councillor Brown expressed concern that the \$50.00 deposit would not cover the actual costs involved to perform the video inspection. Councillor Kilpatrick advised that this was considered at the Operation Committee meeting and it was felt that the video inspection was a service to our residents and it was only a concern when the service was being abused when there was no real reason to conduct the video inspection.

Councillor Steinke moved to concur with the recommendation of the Operations Committee that Policy 35, Sanitary Sewer Blockage Policy be amended to incorporate a \$50.00 deposit fee for video camera inspections. Further that the deposit be returned if it is found that the Town is responsible for repair and maintenance of the line. However the fee would be retained if it was found that no responsibility for repair and maintenance was the Town's. Further that Policy 35, Sanitary Sewer Blockage Policy be approved as presented. — Carried.

A) In regard to the Land Use Bylaw Amendment application to change the Land Use from H (Horticultural) District to R-4 (Manufactured Home Residential District) the Municipal Secretary advised that the property owners intend to develop Lots 21-22, Block 131, Plan 1117V in the near future.
