- A) Councillor Solberg moved correspondence dated October 20, 2011 from Gord's Sharpening regarding a proposal to operate a skate sharpening service at the Redcliff Arena be received for information. Further that Administration be authorized to enter into a Lease Agreement with Gord's Sharpening to provide skate sharpening services at the Redcliff Rec-Tangle conditional to:
 - Gord's Sharpening being responsible for all construction costs, including permits where required.
 - Construction to meet the requirements of the Town of Redcliff.
 - Construction must comply with all Provincial, Federal and Municipal regulations including but not limited to the Alberta Building Code, Alberta Fire Code and Land Use Bylaw.
 - Gord's Sharpening to provide proof of General Commercial Liability Insurance to a minimum coverage of \$2,000,000.00.
 - Rental cost for space in the Rec-Tangle to be \$125.00/month for the skating season from October to April commencing with the 2012-2013 season.
 - Rental costs for 2011 2012 skating season will be waived by the Town of Redcliff.
