- B) Councillor Solberg moved to authorize the sale of Lot 14, Block 12, Plan 0913590 (1201 Memorial Way SE) conditional to consolidation with Lot 15, Block 12, Plan 0913590 [1205 Memorial Way S.E.]. Further that the purchaser be responsible for costs relating to consolidation. Carried.
- C) Municipal Manager advised that the Economic Development Alliance (EDA) is requesting each stakeholder for a letter detailing the expectations they have from the EDA for the contribution each provides. Council members agreed with the three key directives identified in the 3 Year Strategic Plan prepared by the EDA which are:
 - 1) Business Retention and Expansion
 - 2) Investment Attraction and
 - 3) Marketing and Communications.

As well Council members indicated that there should be a focus on increasing communication with the EDA. Also suggested was the promotion of migrant workers. It was noted that further items may be identified once Council members complete the Town of Redcliff's Strategic Plan.

- D) Councillor Steinke moved correspondence from Public Safety Canada dated February 22, 2012 regarding the Royal Canadian Mounted Policy (RCMP) contract be received for information. Further that the Mayor be authorized to sign the Municipal Policing Agreement effective April 1, 2009 to March 31, 2012. Carried.
- E) Councillor Solberg moved to concur with the recommendation of the Public Services Director that the Town of Redcliff authorize the purchase of the Al-Jon Landfill compactor for a cost up to \$559,999 with funding to come from the Landfill reserve. Carried.
- F) Councillor Kilpatrick moved the memo from the Municipal Manager advising the 2012 MSI Capital (\$1,036,051) and MSI Operating (\$1,123,963) grants, reflecting an increase of \$10,585 over 2011 MSI grant contributions be received for information. Carried.
